Surface Lot Event Parking Agreement Options

EasyPark operates several downtown parking lots. These lots are gateless and equipped with electronic pay stations which accept cash and credit cards. The following programs are available upon customer request and tailored for the event parking environment which normally generates high numbers of vehicles. This program is the counterpart for our parking garage validation program and is a convenient way to help ensure a quality parking experience for our mutual customers.

Option 1 – Event Organizer Pays Parking Fees

- Free parking for motorist
- Available for events from one (1) through seven (7) days in duration
- Motorist uses on-site pay station, entering a unique electronic coupon number assigned to the event, the parking space number and the number of parking hours needed
- EasyPark tallies cumulative number of parking hours used
- At event conclusion, EasyPark invoices event organizer the applicable discounted rate based upon total cumulative hours used, less discount, plus a \$30 one-time setup fee

Option 2 – Motorist Pays Parking Fees

- Discount parking for motorist, based upon number of parking hours selected at time of parking transaction
- Motorist uses on-site pay station, entering a unique electronic coupon number assigned to the event, the parking space number and the number of parking hours needed
- Event organizer pays \$30 pay station programming fee
- If cumulative event revenue does not reach a minimum of \$100, event organizer pays the difference
- Available for events from one (1) through seven (7) days in duration

16 - 24 Hour Transaction	\$8.00

Option 3 – Event Organizer Pays Parking Fees

- Free parking for motorist
- Specific parking spaces identified by number and reserved for exclusive use by event organizer, via Luke pay station programming
- Security/EasyPark personnel available for on-site monitoring & control
- At event conclusion, EasyPark invoices event organizer per reserved space, and/or Security/Parking Services labor cost
- Event organizer pays \$30 pay station programming fee
